- Students enrolled in the MOH can join the AIOH as either a student or associate member and after obtaining 5 years of professional experience will be eligible for full membership.
- Students in the MOH are taught the practical aspects of occupational hygiene by experienced AIOH Certified Occupational Hygienists.
- The program includes 240 hours of industry placement where you will undertake an occupational hygiene project with real-life outcomes for workers and industry.
- Some courses in this program may contain enrolment restrictions requiring permission from the Head of School or other approvals. Students are required to email the [School of the Environment](#) to gain approval for restricted courses before they can enrol on SI-Net
